4. PRESENTATION: NCWA's Regional Priorities

General Manager Sicke introduced NCWA's regional priorities related to sustainable groundwater management and NCWA's recent efforts to focus on land subsidence mitigation in the Sacramento Valley. District staff met with NCWA leadership to strategize on GSA-coordination opportunities and one idea that came about is an educational workshop in Yolo County to discuss the quality of DWR's InSAR land subsidence data and opportunities for enhancing data gaps and ensuring quality control. The Directors reviewed NCWA's draft land subsidence statement letter and had comments on some of the language contained within the letter.

5. PRESENTATION: YSGA Update

General Manager Sicke and Assistant General Manager Cadaret presented updates on the YSGA SGMA Implementation Grant funding projects and the YSGA fee study process. Directors asked clarifying questions related to the projects and the fee study.

Directors Tucker and Barth reported attending the District's Groundwater Committee meeting. Director Barth reported attending the YSGA Finance Committee meeting and the Hungry Hollow Groundwater Working Group meeting.
