Monthly statements of water use shall be filed within 30 days of the end of the month in question during the time frame specified, regardless of whether water was used. Water users do not need to file monthly statements after 30-day notice to the District that there will be no further water use. Water users shall file the report covering the period up to the cessation of water use.

Late water use statements will cause a charge of \$50.00 to be added to that month's statement to cover the administrative costs of processing the delinquent account. An additional \$50.00 will be added for every 30 days the statements remain delinquent.

Accounts are due and payable on receipt of invoice and become delinquent 30 days from date mailed. Delinquent accounts are charged a finance charge of 1.5% per month with a 5% end of year penalty charge applied on December 31<sup>st</sup>.

A deposit of **\$30.00** is due as the minimum guaranteed water purchase.
