BACKGROUND:

The District's Capital Improvement Program (CIP) for Fiscal Year 2026/2027 includes the Winters Canal Siphon and Walnut Canal Headgate Replacement Project (Project). The Project will replace a failing 60" siphon that connects Winters Canal in the southwest portion of the canal system and runs underneath Chickahominy Slough. As part of replacing the siphon, the District will also be replacing the concrete inlet and outlet connected to the Winters Canal at this location, along with upgrading the gate that drops water into the heading of the Walnut Canal (also known as Chickahominy Slough) for irrigation deliveries to the east. The District is prioritizing the project for completion prior to the 2026 irrigation season.

Davids Engineering is assisting the District with engineering and soliciting the project for contractor bidding, as well as providing engineering services, field inspection, and biological monitoring services during construction.

A Notice of Exemption for the Project per the California Environmental Quality Act (CEQA) was filed on September 19, 2025. The Project is exempt from CEQA pursuant to CEQA Guidelines 15302(c).

The bid period for the Project began on December 17, 2025, and 8 bids ranging from \$529,897 to \$2.14 M were received on January 26, 2026. The engineer's estimate was approximately \$913,000. The apparent low bid was received from Diamond D General Engineering; however, Diamond D did not provide Surety acknowledgement or signature to Section 1.8 Acknowledgement of Insurance and Bonding Requirements, nor provide signed acknowledgement of Section 2.4

Contractor's Workers' Compensation Certificate with their bid. Section 4.15 – Award of Contract of the Instructions to Bidders (Page 6) clearly states that failure to provide the required bid bond documentation may result in the award of the next lowest responsive, responsible, bidder.

The District will elect to deem Diamond D General Engineering bid non-responsive for the reasons above and plan to award the project to the next lowest, responsive bidder. The next low bid was received from Escheman Construction Company (see the summary of bid results below).

Staff recommends the Board award the construction contract for the Project to Escheman Construction Company the lowest responsive, responsible bidder, in an amount not to exceed \$1,095,382.50.

The contract time for the Project is 85 calendar days and is estimated to be completed by May 6, 2026.

Staff will provide a brief update on preparing for the project, and provide the Board an opportunity to review the summary of bid results.

RECOMMENDATION:

Staff recommends the Board award a contract to the lowest responsive, responsible bidder, Escheman Construction Company, in an amount not to exceed \$1,095,382.50 for the Winters Canal Siphon and Walnut Canal Headgate Replacement Project.
